Yearly Plan: Tuition paid annually in advance is given a \$200 discount for all students attending a full 5 day program and \$100 for all students attending part time programs. *Annual tuition is due by February 15, 2008.*

Monthly Plan: Monthly tuition payments will be made through FACTS Tuition Management by ACH Debit or credit card charge. If the tuition payment does not occur, due to insufficient funds, a \$25 fee will be assessed.

Ten (10) monthly installments for Preschool through 12th grade, the first of which is due by March 5, 2008, and each month thereafter through December 5, 2008.

Twelve (12) monthly installments for ELC Extended Year Options, the first of which will be September 08, continuing through August 09, or nine (9) monthly installments for the ELC School Year Option, the first of which will be September 08-May 09 .

Multiple Child Discounts: ELC – Preschool – Students enrolled in ELC-Preschool are not given a tuition discount.

KP-12th - Families with more than one child attending POPCS will receive a \$500 per student discount beginning with the 2nd child.

Registration/Enrollment Fees: Fees are due upon enrollment. Registration/Enrollment Fees are non-refundable unless the family is not being granted enrollment due to waiting list or other school-determined reason.

School Tuition, Registration Fees for School, ELC and The Zone, and Enrollment Fees are non-refundable.

ELC prepaid tuition is refundable due to withdrawal with two weeks notice. The Zone (ESS) tuition, except for holiday care, is transferable or refundable if withdrawal from before/after-school care is necessary.

I/We promise to pay the full tuition amount of \$ _____ by using the _____ plan. If I/we fall more than 2 payments behind in paying tuition, I/we will receive notice. If our accounts are not current within 14 days from the date of the notice, our child(ren) will be asked to withdraw. Enrollment for the following year (2009-2010) is subject to full payment of 08-09 tuition and fees by January 31, 2009. A charge of \$25.00 will be assessed for any returned check. After two returned checks, I/we will be required to make our payments with cash or money order.
